CERTIFICATE OF INCORPORATION

OF

MARYLAND CONGRESS OF PARENTS AND TEACHERS, INC.

THAT IS TO CERTIFY:

First. That we, the subscribers, Edna P. Cook, whose Post Office address is Indian Head, Charles County, Maryland; Mabel F. Coppage, whose Post Office address is No. 3510 Fairview Avenue, Baltimore, Maryland; and Mildred M. Clements, whose Post Office address is No. 7 Thompson Street, Annapolis, Maryland; all being of full age, and, under and by virtue of the General Laws of the State of Maryland authorizing the formation of corporations, associate ourselves with the intention of forming a corporation.

Second. That the name of the corporation is:

MARYLAND CONGRESS OF PARENTS AND TEACHERS, INC.

Third. The purposes for which the corporation is formed and the business and objects to be carried on and promoted by it are as follows:

To promote the welfare of children and youth in home, school, church and community.

To raise the standards of home life.

To secure adequate laws for the care and protection of children and youth.

To bring into closer relation the home and the school that parents and teachers may cooperate intelligently in the training of the child.

To develop between educators and the general public such united efforts as will secure for every child the highest advantages in physical, mental, social and spiritual education.

Fourth. The Post Office address of the place at which the principal office of the corporation in this State will be located is Indian Head, Charles County, Maryland. The resident agent of the corporation is Edna P. Cook, whose Post Office address is Indian Head, Charles County, Maryland. Said resident agent is a citizen of the State of Maryland and actually resides therein.

FIFTH. The corporation shall have three directors, and Edna P. Cook, Mabel F. Coppage and Mildred M. Clements shall act as such until the first annual meeting or until their successors are duly chosen and qualify. The number of directors may be changed in such lawful manner as the by-laws may from time to time provide.

Sixth. The total amount of authorized capital stock of the corporation is none. Its objects are non-commercial as set forth in Paragraph Three.
