

Set forth the name of the limited liability company in paragraph 1 exactly as it appears in its articles of organization, as amended, without alteration or abbreviation.

If the limited liability company's name does not contain the abbreviation **L.C.**, **LC**, **L.L.C.** or **LLC**, or the words **limited company** or **limited liability company**, it must adopt a designated name for use in Virginia that **adds** one of the foregoing to its name.

The limited liability company's name must be distinguishable upon the records of the Commission. See § 13.1-1054 of the Code of Virginia.
