the certificate of registration issued to the aforementioned business trust is reinstated.

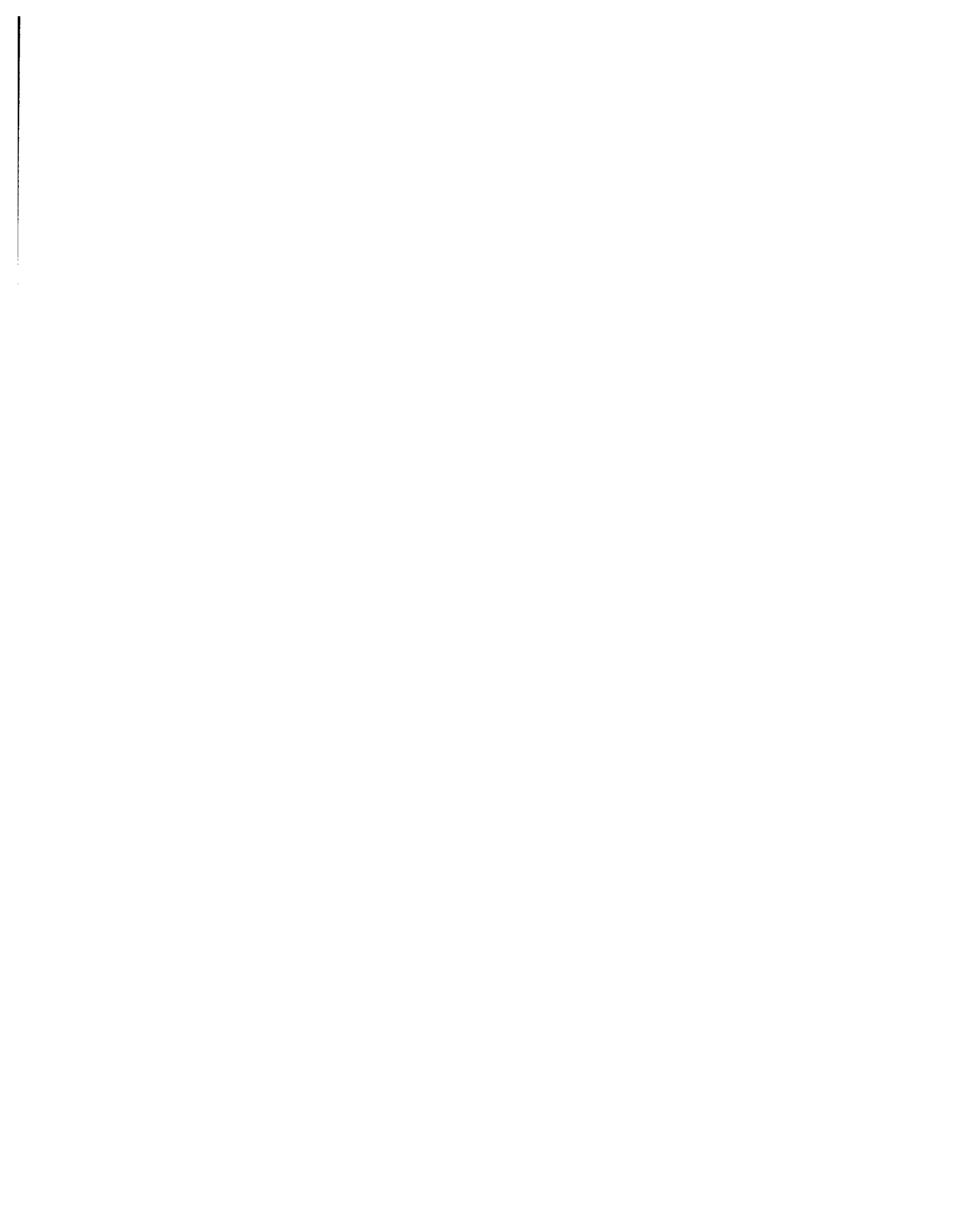
The reinstatement is effective February 17, 2009.

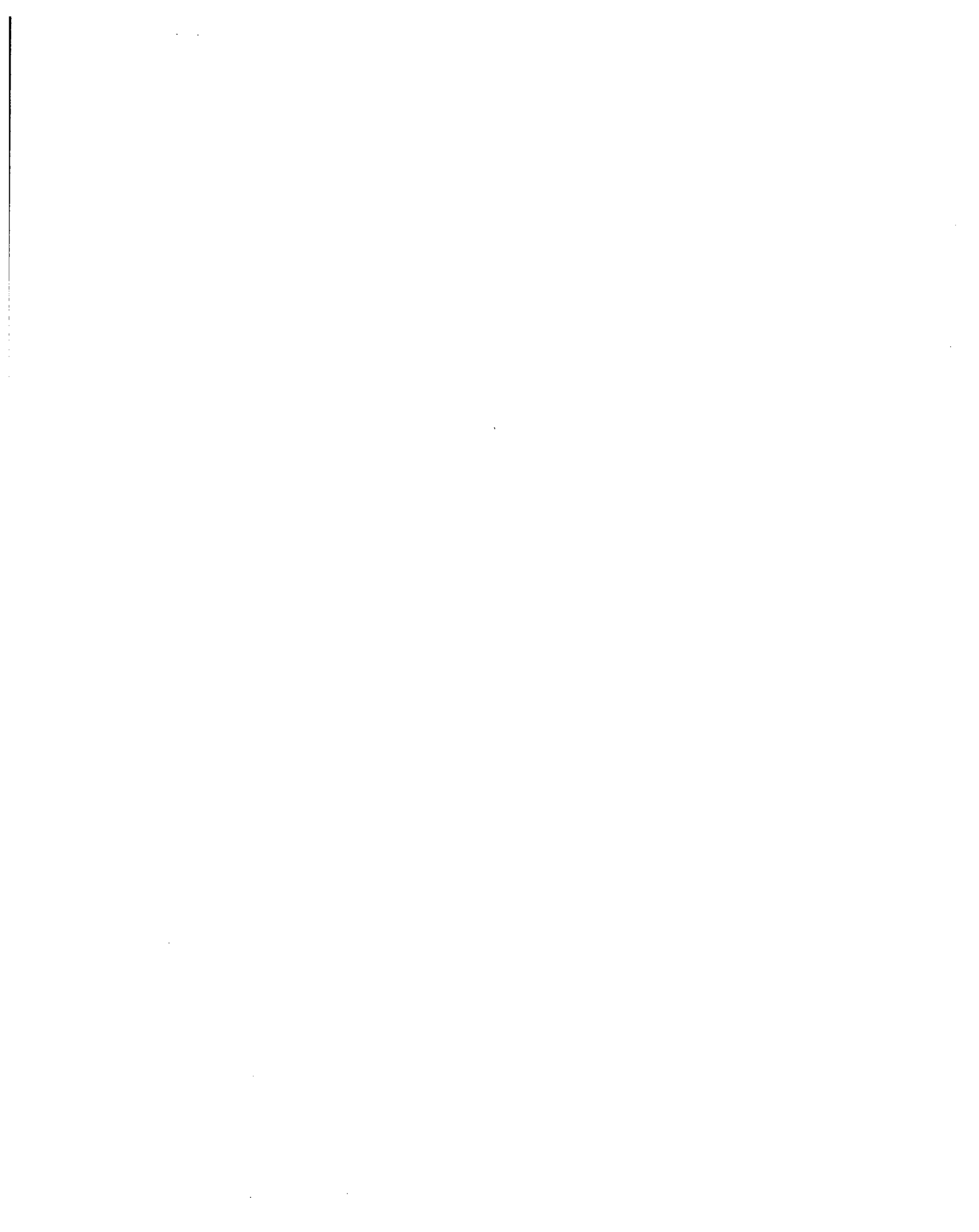
