

ARTICLES OF ORGANIZATION
OF
TD Hanover, LLC

Pursuant to Chapter 12 of Title 13.1 of the Code of Virginia, the undersigned states as follows:

Article I. Name. The name of the limited liability company (the "Company") is:

TD Hanover, LLC


Article II. Registered Office and Agent. The post office address of the initial registered office of the Company is located within the City of Charlottesville, at 250 East High Street, Charlottesville, Virginia 22902. The initial registered agent is David W. Kudravetz, whose business address is the same as the post office address of the initial registered office, and who is a resident of the state of Virginia and member of the State Bar.

Article III. Principal Office. The principal office of the Company is located at 540 Park Street, Charlottesville, Virginia 22902.

Article IV. Written Operating Agreement. Any operating agreement entered into by the members of the Company, and any amendments or restatements thereof, shall be in writing. No oral agreement among any of the members or managers of the Company shall be deemed or construed to constitute any portion of, or otherwise affect the interpretation of, any written operating agreement of the Company, as amended and in existence from time to time.

Article V. Manager-Managed Company. The Company shall be a "manager-managed limited liability company" within the meaning of the Act, and no member of the Company, solely by reason of such member's membership in the Company, shall be considered or relied upon to be an agent of the Company for the purpose of binding the Company with respect to any transaction or other obligation whatsoever.
