



ARTICLES OF ORGANIZATION OF TO Hanover, UC

Pursuant to Chapter 12 of Title 13.1 of the Code of Virginia, the undersigned states as follows:

Article I. Name. The name of the limited liability company (the "Company") is:

TD Hanover, UC

Article II. Registered Office and Agent. The post office address of the initial registered office of the Company is located within the City of Charlottesville, at 250 East High Street, Charlottesville, Virginia 22902.
