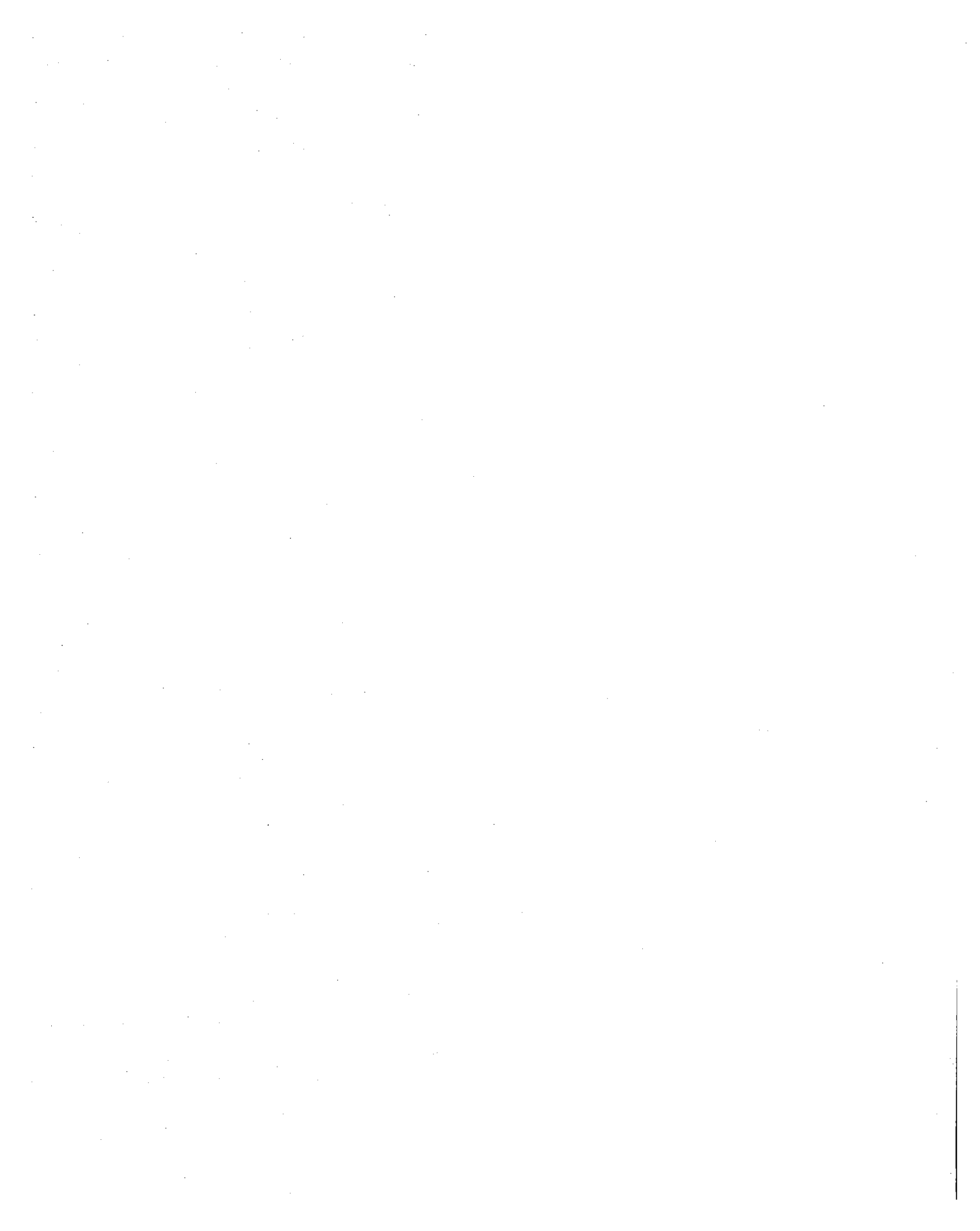

1. **Name:** The name of the limited liability company is 501 22nd Street, LLC.


