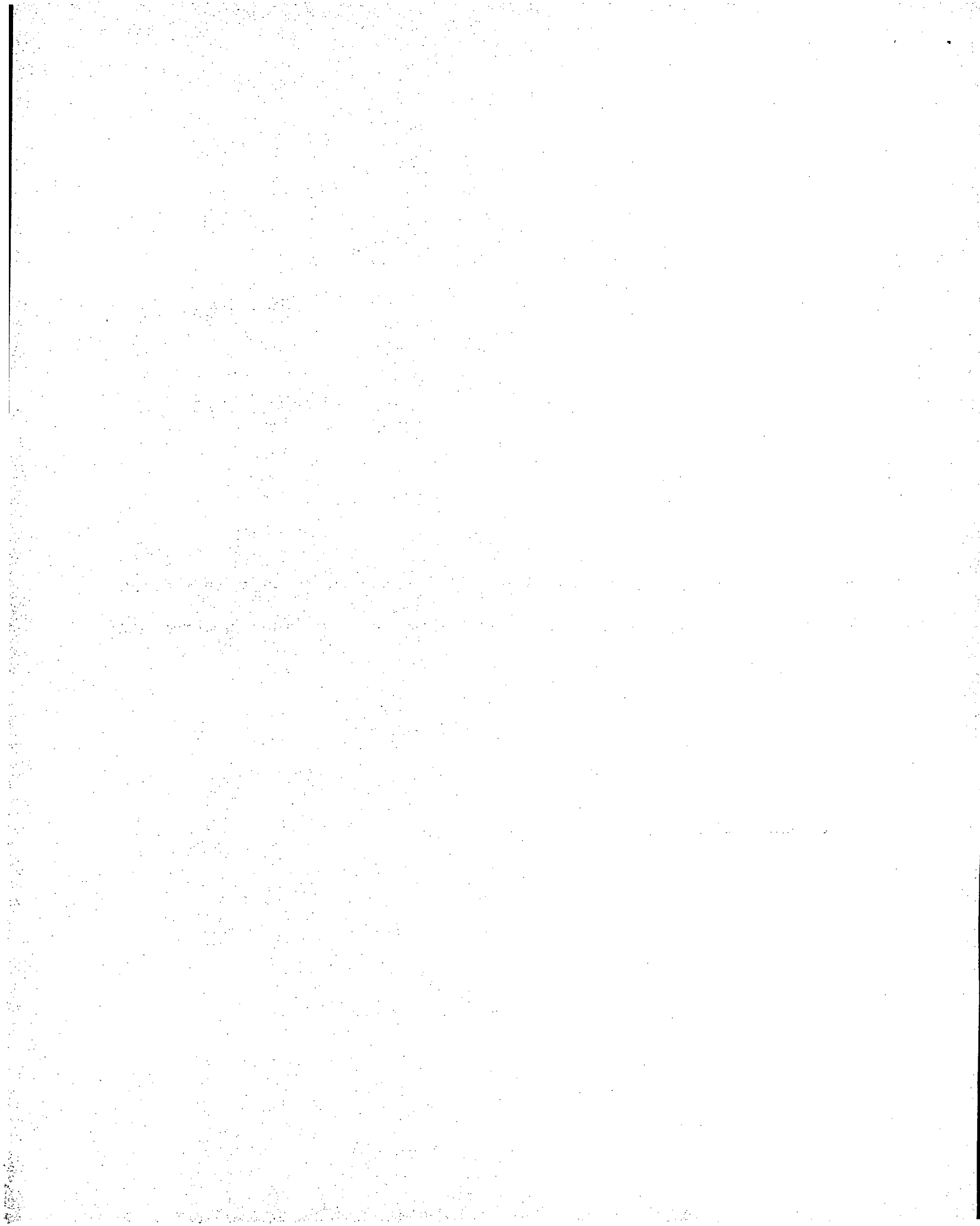

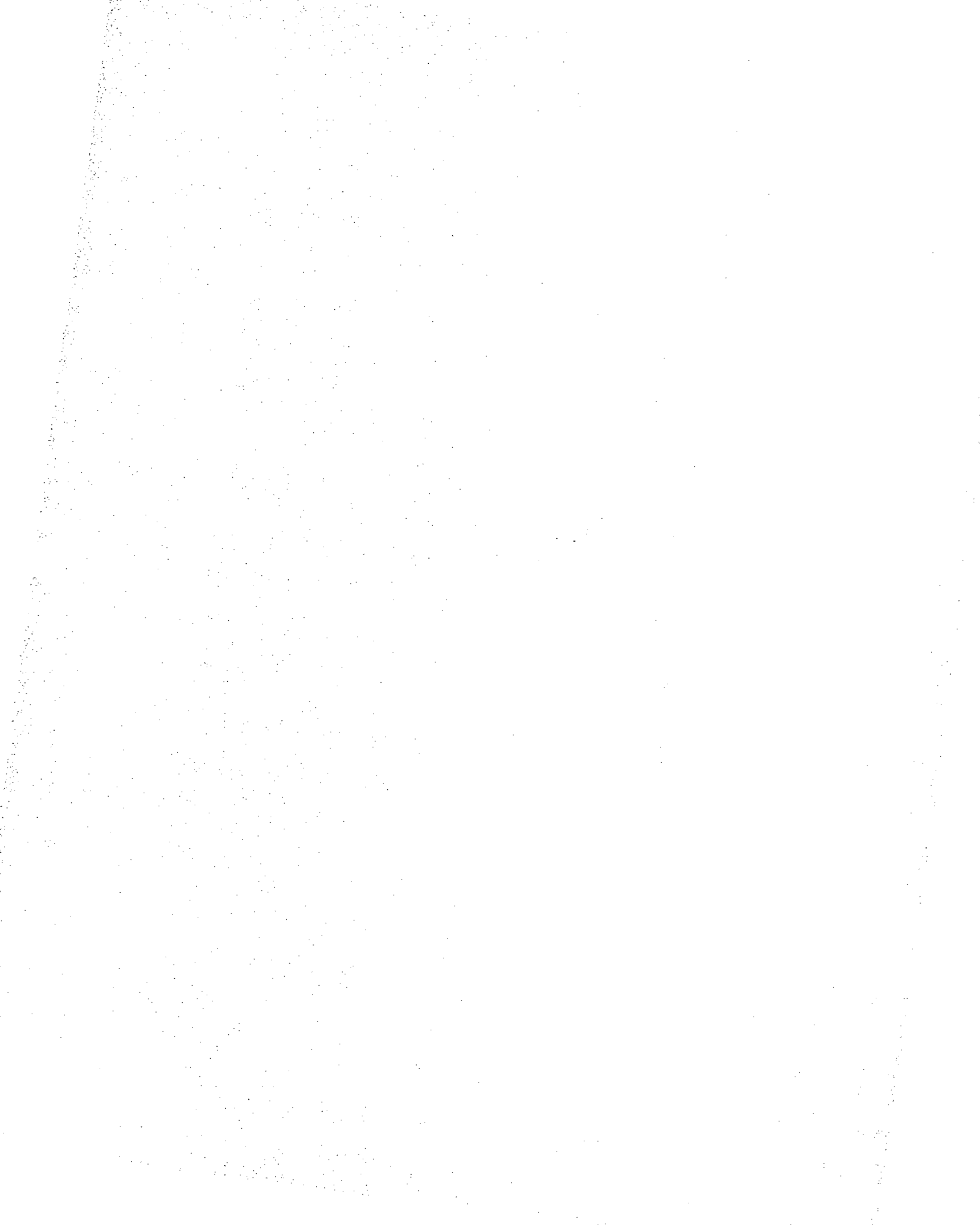



We hereby associate to form a limited liability company under the provisions of §13.1-1000 of the Code of Virginia, 1950, as amended, and to that end set forth the following:


1. The name of the limited liability company is P. C. REPAIR SERVICES OF VIRGINIA, LLC.
