

ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF THE SHOPS AT WHITE OAK VILLAGE COMMUNITY DEVELOPMENT AUTHORITY

The undersigned, pursuant to Chapter 51, Title 15.2 of the Code of Virginia, adopts the following Articles of Amendment of The Articles of Incorporation of The Shops at White Oak Village Community Development Authority (the "Authority") and states as follows:

- 1. The name of the Authority is The Shops at White Oak Village Community Development Authority, a public body politic and corporate and political subdivision created by Resolution duly adopted by the Board of Supervisors of Henrico County. Virginia (the "Board"), and governed by the laws of the Commonwealth of Virginia.
- 2. By Resolution adopted by the Board on May 22, 2007, the Board amended the geographic boundaries of the Authority District and established such boundaries as set forth in Exhibit A attached hereto. Therefore, the Articles of Incorporation of the Authority are hereby amended to delete the existing Exhibit A and substitute therefor the attached Exhibit A. The text of the amendment adopted is as follows:

Delete Article V and substitute therefor:

Article V

Authority District

The land encompassed within the Authority is set forth in <u>Exhibit A</u> attached hereto (the "Authority District"), provided that the Authority Board may release and exclude from the Authority District before or after the issuance of the Authority's bonds certain de minimis portions of land not to exceed approximately one acre. In addition, the Authority's Board may release and exclude from the Authority District portions of land with respect to which all special assessments have been paid or prepaid.


