We, the undersigned, all of whom are persons of full age, citizens of the United States, and a majority of whom are citizens and residents of the District of Columbia, desiring to associate ourselves as a corporation pursuant to the provisions of Title 5, Chapter 5, of the Code of the District of Columbia, as amended, do hereby certify as follows:

First: The name or title by which this corporation shall be known in law shall be **MOTHERS HEALTH ASSOCIATION OF THE DISTRICT OF COLUMBIA.**

Second: The term for which this corporation is organized shall be perpetual.

Third: The particular business and objects of said corporation shall be:

(a) To establish, maintain or operate, or to aid in the establishment, maintenance or operation of health centers or clinics within the District of Columbia, or elsewhere, which will provide or furnish contraceptive advice and treatment through licensed physicians and in accordance with sound medical principles.

(b) To acquire in its corporate name real, personal or mixed property by gift, grant, purchase, conveyance, devise, bequest or otherwise; to dispose of any of its property by gift, grant, bargain, sale, conveyance or otherwise; to borrow money and to secure the repayment thereof by mortgage or deed of trust of any of its property or by pledge of any of its personal property.

(c) In general to do and perform every act and thing necessary or expedient to be done or performed in connection with the foregoing powers and to have and exercise all the powers conferred by the laws of the District of Columbia upon corporations organized under Title 5, Chapter 5 of the Code of the District of Columbia, as amended.



ARTICLES OF AMENDMENT TO THE
STATEMENT OF ELECTION OF
PLANNED PARENTHOOD OF

Pursuant to the provisions of the District of Columbia Nonprofit Corporation Act, the undersigned adopts the following Articles of Amendment to its Statement of Election:

FIRST: The name of the corporation (before adoption of these Articles) has been PLANNED PARENTHOOD ASSOCIATION OF METROPOLITAN WASHINGTON, D.C., INC.

SECOND: The following amendments of the Statement of Election were adopted by the corporation in the manner prescribed the District of Columbia Nonprofit Corporation Act:


1. The statement of the name of the corporation in paragraph one shall be amended as follows:

FIRST: The name of the corporation is PLANNED PARENTHOOD OF METROPOLITAN WASHINGTON, D.C., INC.

2. The statement of business and objects of the corporation as set forth in the paragraph 4(a) shall be amended as follows:

FOURTH: The particular business and objects of the corporation shall be:

(a) to establish, maintain or operate or to aid in the establishment, maintenance or operation of health centers or clinics within the District of Columbia,

or elsewhere, which will provide or furnish birth control assistance in accordance with sound medical principles;

3. Paragraph 5 is amended to read as follows:

FIFTH: The corporation shall have members, which shall be divided into such classes as shall be provided in the Bylaws. All members shall be accepted, appointed, elected or designated in the manner provided in the Bylaws. The qualifications and rights, including voting rights, of members shall be provided in the Bylaws.

THIRD: The amendments were adopted at a meeting of members held on May 14, 1981, at which a quorum was present, and the amendments received at least two-thirds of the votes that members present or represented by proxy at such meeting were entitled to cast.



STATEMENT OF ELECTION TO ACCEPT CHAPTER 10
OF THE DISTRICT OF COLUMBIA CODE, TITLE 29
BY PLANNED PARENTHOOD ASSOCIATION OF
METROPOLITAN WASHINGTON, D.C., INC.

Pursuant to the provisions of the District of Columbia Nonprofit Corporation Act, Chapter 10, Title 29 of the Code of the District of Columbia, the undersigned corporation elects to avail itself thereof.


FIRST: The name of the corporation is PLANNED PARENTHOOD ASSOCIATION OF METROPOLITAN WASHINGTON, D.C., INC.

SECOND: A resolution that the corporation accept the District of Columbia Nonprofit Corporation Act was adopted at a meeting of the members having voting rights held on May 14, 1981, at which meeting a quorum of the members having voting rights was present, and the resolution received the affirmative vote of at least two-thirds of the members having voting rights present or represented by proxy at that meeting.

THIRD: The term of the corporation shall be perpetual.

FOURTH: The particular business and objects of the corporation shall be:

(a) to establish, maintain or operate or to aid in the establishment, maintenance or operation of health centers or clinics within the District of Columbia, or elsewhere, which will provide or furnish birth control assistance through licensed physicians and in accordance with sound medical principles;

(b) to acquire in its corporate name real, personal or mixed property by gifts, grant, purchase, conveyance, devise, bequest, or otherwise; to dispose of any of its property by gift, grant, bargain, sale, conveyance or otherwise; to borrow money and to secure the payment thereof by mortgage or deed of trust of any of its property or by pledge of any of its personal property; and

(c) in general to do and perform every act and thing necessary or expedient to be done or performed in connection with the foregoing powers and to have and exercise all the powers conferred by law of the District of Columbia upon corporations organized under Title 29, Chapter 10, of the Code of the District of Columbia, known as the District of Columbia Nonprofit Corporation Act.

FIFTH: The corporation is to be divided into two classes of members. The designation of each class of members, the qualifications, rights and limitations of the members of each class and conferring, limiting or denying the right to vote are as follows:

(a) Voting Members shall be members of the corporation's Board of Directors and members of the corporation's chapter councils, described in Article VIII of the corporation's bylaws. Voting Members shall be entitled to transact all business presented at the Annual Meeting, or at Special Meetings, and shall be entitled to elect the Board of Directors and the Chairman of the corporation's Nominating Committee.

(b) General Members shall be members of the corporation's committees, and all persons who contribute either through service or financially to the corporation, provided that they subscribe to the purpose of the corporation as set forth in the Bylaws. General Members shall not have the right to vote at the Annual Meeting or Special Meetings, but may attend and speak at those meetings and may propose to the Nominating Committee of the corporation the names of persons to be considered for membership on the Board of Directors.

SIXTH: The affairs of the corporation shall be managed by a Board of Directors, the members of which shall be elected in the manner provided in the bylaws.

SEVENTH: Provisions for the regulation of the internal affairs of the corporation are contained in the bylaws.

EIGHTH: If the corporation should dissolve, any remaining assets after payment of debts shall be used exclusively for educational and charitable purposes within the contemplation of Section 501(c)(3) of the Internal Revenue Code.

NINTH: The address of the registered office in the District of Columbia of the corporation is 1108 Sixteenth Street, N.W., Washington, D.C., and its registered
