

ARTICLES OF ORGANIZATION

OF

ASSOCIATED CLARK FAMILY, LLC

The undersigned, desiring to form a limited liability company under the provisions of Chapter 12 of Title 13.1 of the Code of Virginia of 1950, as amended, hereby sets forth the following:

Name. The name of the limited liability company is ASSOCIATED Article I. CLARK FAMILY, LLC (the "Company").
