ARTICLES OF ORGANIZATION

OF

ASSOCIATED CLARK FAMILY, LLC

The undersigned, desiring to form a limited liability company under the provisions of Chapter 12 of Title 13.1 of the Code of Virginia of 1950, as amended, hereby sets forth the following:

Article I. Name. The name of the limited liability company is ASSOCIATED CLARK FAMILY, LLC (the "Company").


Article II. Registered Office and Registered Agent. The initial registered office of the Company shall be located in the City of Richmond, Virginia and the post office address of the initial registered office shall be Two James Center, 17th Floor, 1021 East Cary Street, Richmond, VA 23219. The initial registered agent of the Company shall be John M. Mercer who is a resident of Virginia, a member of the Virginia State Bar and whose business address is identical with the registered office of the Company.

Article III. Principal Office. The principal office of the Company is located at 1705 Brook Road, Richmond, Virginia 23220.

Article IV. Management. The Company shall be managed by one or more Managers, whose identities and terms of office shall be set forth in the written Operating Agreement of the Company.

Article V. Written Operating Agreement. Any operating agreement entered into by the members of the Company, and any amendments or restatements thereof, shall be in writing. No oral agreement among any of the members or managers of the Company shall be deemed or construed to constitute any portion of, or otherwise affect the interpretation of, any written operating agreement of the Company, as amended and in existence from time to time.
