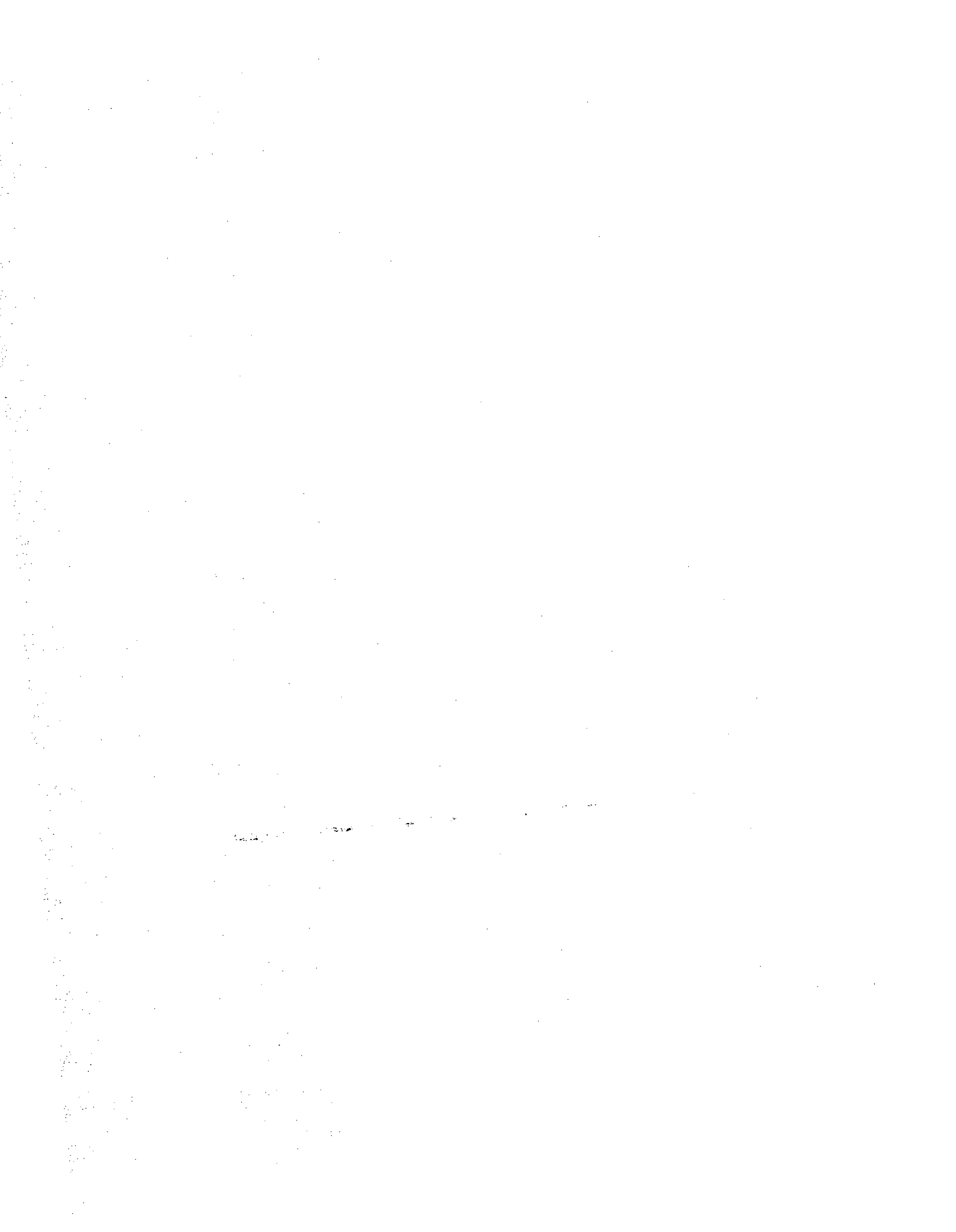

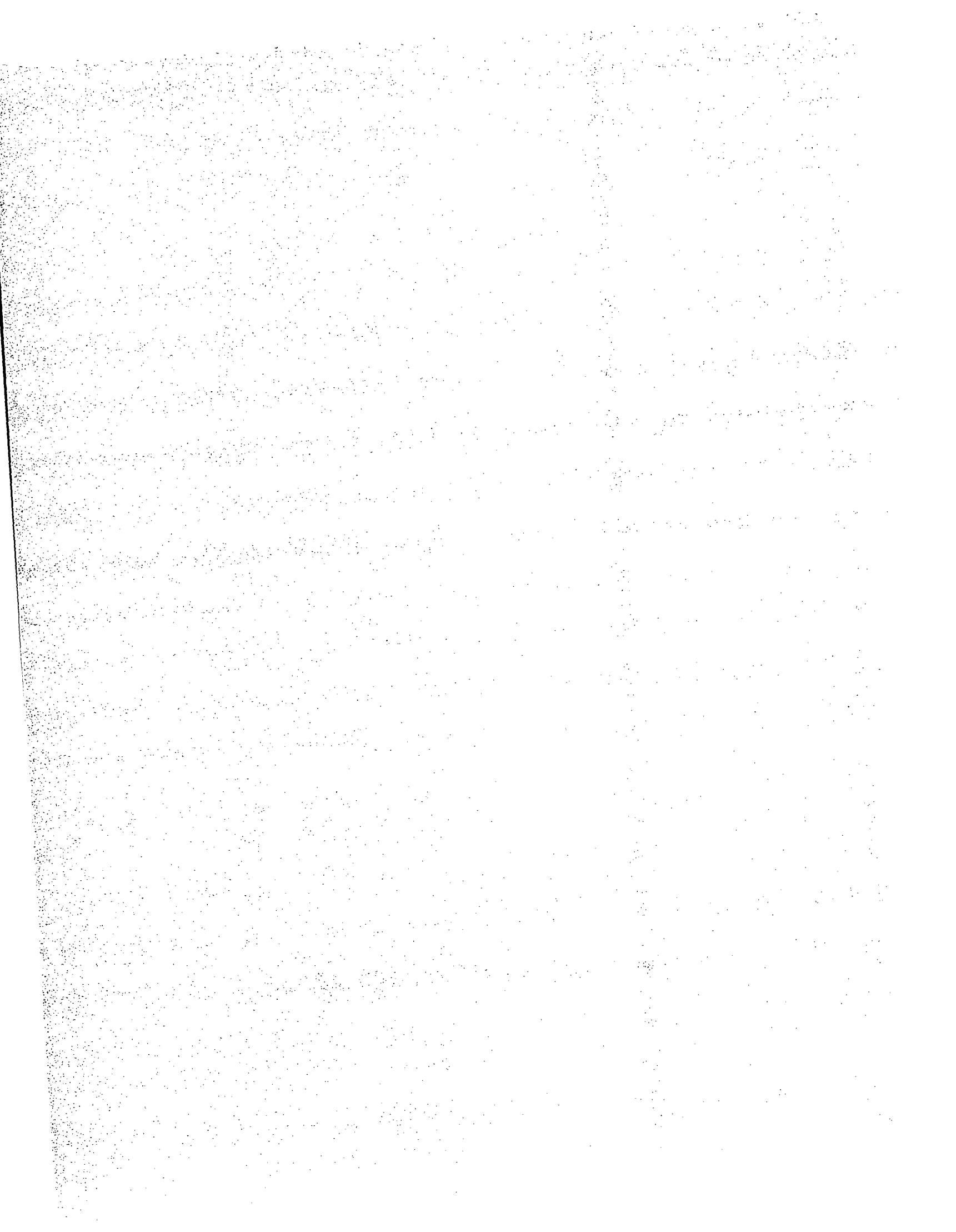

ARTICLES OF ORGANIZATION  
OF

The undersigned desires to form a limited liability company under the provisions of Chapter 12 of Title 13.1 of the Code of Virginia, 1950, as amended, and to that end sets forth the following:

ARTICLE I  
Name

The name of the limited liability company is:
