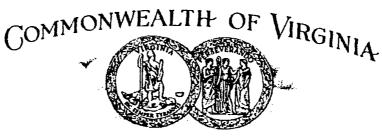

### PLAN OF ENTITY CONVERSION

This Plan of Entity Conversion (the "<u>Plan</u>") is made this 20th day of July, 2004, by Sunset Memorial Gardens, Inc., a Virginia corporation (the "<u>Corporation</u>") and its sole shareholder, Sunset Memorial Gardens Subsidiary, Inc., a Virginia corporation (the "<u>Shareholder</u>").

## WITNESSETH

WHEREAS, the Board of Directors of the Corporation unanimously deemed it desirable and in the best interests of the Corporation and its sole Shareholder for the Corporation to be converted into a Virginia limited liability company (the "<u>Conversion</u>") as authorized, approved and directed by the Board of Directors which adopted this Plan; and,

WHEREAS, the sole Shareholder of the Corporation also deemed the Conversion desirable and in the best interests of the Corporation and itself as authorized, approved and directed by the sole Shareholder which approved this Plan;

NOW, THEREFORE, the Corporation and sole Shareholder, by their duly authorized undersigned Officers, as authorized, approved and directed by their respective Boards of Directors, in consideration of the mutual covenants, agreements and provisions herein contained, and for other good and valuable consideration, and intending to be legally bound, do hereby agree upon and prescribe the terms and conditions of the Conversion, and provide for the Conversion set forth in this Plan, and the mode of carrying them into effect, in accordance with the laws of the Commonwealth of Virginia as follows:

1. <u>Conversion</u>. In accordance with the provisions of the Virginia Stock Corporation Act and the Virginia Limited Liability Company Act (collectively, the "<u>Act</u>"), at the Effective Time (as hereinafter defined), the Corporation shall be converted to and become a Virginia limited liability company named Sunset Memorial Gardens LLC (the "<u>LLC</u>").

2. <u>Effective Time</u>. The Effective Time of the Conversion shall be upon the filing of the Articles of Entity Conversion of the Corporation and the Articles of Organization of the LLC (as hereinafter attached) with the State Corporation Commission of the Commonwealth of Virginia subject to issuance of a certificate of entity conversion by the State Corporation Commission (the "<u>Effective Time</u>").

3. <u>Conversion of Shares</u>. At the Effective Time of the Conversion, all of the issued and outstanding shares of capital stock, including treasury stock, of the Corporation, shall automatically be cancelled and become of no effect whatsoever with respect to the Corporation, and/or the LLC, and shall automatically be converted into units of limited liability company membership interests in the LLC, with the sole Shareholder of the Corporation holding 100% of the units of limited liability company membership interests in the LLC and being the sole member of the LLC ("<u>Member</u>"). Each share of stock of the sole Shareholder of the Corporation immediately prior to the Effective Time of the Conversion shall be so converted into one unit of limited liability company membership interest in the LLC held by the sole Shareholder as the sole Member of the LLC. · · · ·

4. <u>Articles of Organization</u>. Attached hereto as <u>Appendix 1</u> to this Plan are the Articles of Organization of the LLC, to be filed with the State Corporation Commission of the Commonwealth of Virginia, to be in effect immediately upon the Effective Time of the Conversion unless and until such Articles are modified after the Effective Time in accordance with the Virginia Limited Liability Company Act.

5. <u>Articles of Entity Conversion</u>. Attached as <u>Appendix 2</u> to this Plan are the Articles of Entity Conversion of the Corporation to be filed with the State Corporation Commission of the Commonwealth of Virginia.

6. <u>Managers</u>. At the Effective Time of the Conversion, the directors of the Corporation immediately prior to the Effective Time shall become the managers of the LLC. Each such manager in the LLC shall hold such office until the expiration of his term of office being served immediately prior to the Effective Time of the Conversion, or his earlier death, resignation or removal by the sole Member in accordance with the Articles of Organization and the Operating Agreement of the LLC and applicable law.

7. <u>Officers</u>. At the Effective Time of the Conversion, the officers of the Corporation immediately prior to the Effective Time shall become the same officers of the LLC. Each such officer in the LLC shall hold such office until the expiration of his term of office being served immediately prior to the Effective Time of the Conversion, or his earlier death, resignation or removal by the managers in accordance with the Articles of Organization and the Operating Agreement of the LLC and applicable law.

8. <u>Assets</u>. At the Effective Time of the Conversion, all property real, personal, and mixed owned by the converting Corporation; all rights, privileges, immunities, licenses, permits and franchises of the converting Corporation, of a public as well as a private nature; and all debts or obligations due the converting Corporation; are taken and deemed to remain and be vested in the resulting LLC without the necessity of any deed or other instrument of conveyance to the resulting LLC.

9. <u>Liabilities</u>. At the Effective Time of the Conversion, the resulting LLC shall remain and be responsible and liable for all the liabilities and obligations of the converting Corporation. Neither the rights of creditors, nor any liens upon the property of the converting Corporation shall be impaired by the Conversion.

10. <u>Effect</u>. The Conversion shall have the effects set forth in Section 13.1-722.13 of the Virginia Stock Corporation Act. Without limiting the generality of the foregoing, and subject thereto, the Corporation shall continue its existence in the form of the LLC as a limited liability company under the laws of the Commonwealth of Virginia. The resulting LLC from the converted Corporation, upon the Effective Time of the Conversion, is for all purposes the same business entity that existed before the conversion as provided by the Act.

11. <u>Amendment</u>. This Plan may be amended by the Board of Directors of the Corporation and sole Shareholder at any time prior to the issuance of the certificate of entity conversion by the State Corporation Commission of the Commonwealth of Virginia.

12. Governing Law. This Plan, the Articles of Entity Conversion, the Articles of Organization and such other documents as are necessary and appropriate to implement this Plan shall be filed as required by the laws of the Commonwealth of Virginia with the State Corporation Commission of Virginia and shall be governed by and construed in all respects in accordance with the laws of the Commonwealth of Virginia.
