**AMENDED AND RESTATED
ARTICLES OF INCORPORATION**

MERTULEMARIAM

Resolving to revise the purposes of the organization, By Unanimous Consent of the board of directors, the undersigned, pursuant to § 13.1-888 of the Code of Virginia, executes these articles and state as follows:

ARTICLE I NAME

The name of the incorporation is MERTULEMARIAM

ARTICLE II PURPOSES

The organization is formed and shall be operated exclusively for charitable purpose as provided under section 501(c) (3) of the Internal Revenue Code. Its specific purposes shall be to:

- Support productive and innovative Education
- Empower women and increase overall participation
- Support children with disabilities in education and rehabilitation
- Contribute to and support the reservation of religious and cultural resources

ARTICLE III Prohibition of benefit distribution

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in its Article of Incorporation or by law or its rules and procedure.

ARTICLE IV MEMBERSHIP

The Organization shall have members. However, there shall be no special class of membership. All members shall be voting members.

ARTICLE V

Mertulemariam shall have board of directors to be elected by the members.

ARTICLE VI REGISTERED AGENT

The name of the registered agent is Abebe Tsegie, whose address is

ARTICLE VII Registered office

The Organization's registered office address is 8650 Venoy Ct., Alexandria, VA 22309

ARTICLE VIII Prohibition of political activity

Mertulemariam shall not, as a substantial part of its activities, attempt to influence legislation nor shall it participate to any extent in a political campaign for or against any candidate for public office.

ARTICLE IX Dissolution

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the

meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or

shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the

corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
