# Articles of Amendment of

# Grace and Mercy Cathedral

The undersigned, on behalf of the nonstick corporations set forth below, pursuant to Title 13.1, Chapter 10, Article 10 of the Code of Virginia, states as follows:

- 1. The name of the corporation is Grace and Mercy Cathedral.
- 2. The current name of organization is now changed to: <u>Grace and Mercy Church Of</u> <u>God In Christ</u>
- 3. The foregoing amendment(s) were adopted by the corporation on *Feb. 23, 2010*.
- 4. The additions and or Amendments to the original Articles of the corporation were adopted by unanimous consent of the members as per the following:
  - 7. Said church organized exclusively for religious, charitable, and educational purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organization under Section 501(c)(3) of the Internal Revenue Code (or the corresponding provisions of any future United States Internal Revenue Law).
  - 8. Nothing in "the church" by-laws and constitution shall be in contravention of, and/or repugnant to the laws, rules, regulations and the By-Laws and Constitution of The Church OF God In Christ, Inc. (The National Church, a hierarchical organization), a Tennessee parent corporation headquartered in Memphis, Tennessee.
  - 9. Membership. "The church "shall consist of one class of membership. The qualifications and rights of said members including, but not limited to the right to vote are contained in the constitution and by-laws of "the church".
    They are further enunciated in The Official Manual of The Church Of God

In Christ, Inc. However, no part of the net earning of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its proposes.

10. No substantial part of the activities of "the church" shall be carrying on of propaganda or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in (excluding the publishing or distributions of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, "the church" shall not carry on any other activities not permitted to be carried on (a) by a church exempt for Federal income tax under Section 501(c)(3) of the Internal Revenue Code (or the corresponding provisions of any future United States Internal Revenue Law) or (b) a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code (or the Internal Revenue Code) (or the corresponding provisions of any further United States Internal Revenue Law).

- 11. The election of Trustees shall be:
  - A. Time and manner for the election of new Trustees:

Trustees shall be elected by the Pastor for such terms as the By laws may provide. The methodology of selection may be changed as

dictates of the Church requires. The number of trustees may be increased or decreased in the manner provided by the By-laws, but shall never be less than three (3).

- B. Qualifications of those able to vote for and be elected as a Trustee: The exact qualifications of those eligible to vote at elections and to be elected to office are those who are in good standing with the Church, i.e., faithful to Biblical principle, faithful in attendance and faithful in tithes and financial support. (See # 2 above)
- C. The Constitution and By-laws of the Church shall set forth and prescribe the manner in which all officers, directors, and officials of the Church shall be elected and appointed. Provisions for the regulation of the internal affairs of the Corporation shall be governed by the Constitution and By-laws of the Church in conjunction with the provisions of The Official Manual of Church of God In Christ, Inc. (See #2 above)
